Attendees will also gain strategic perspective through CLARB’s environmental scan and participate in the collaborative MBE Exchange.

More than 125 landscape architecture regulatory professionals from across the United States, Canada, Puerto Rico and the Northern Mariana Islands are expected to gather in Calgary for this event.
